ACRU's Broward County Trial Opens in Miami

Sun-Sentinel: Broward County could have thousands of ineligible voters on its rolls, increasing the risk of voter fraud, because its election officials don't do enough to keep the lists accurate, according to a national group that has challenged voter rolls across the country. In a lawsuit, the American Civil Rights Union, a conservative group started by a former official in President Ronald Reagan's administration, contends that in recent years Broward's voting lists have included more names than the number of voting-age people living in the county.

Broward Elections Supervisor to Testify in Federal Voter Roll Lawsuit

Miami Herald: Broward Supervisor of Elections Brenda Snipes is expected to testify Monday (July 31) in a lawsuit that alleges she has failed to adequately purge voter rolls of ineligible voters including those who have died. The lawsuit was filed on behalf of the conservative American Civil Rights Union in federal court in 2016. The ACRU is being represented by the Public Interest Legal Foundation, which has filed similar lawsuits in other states including North Carolina, Virginia and Texas. The president and general counsel of the foundation, J. Christian Adams, is a member of President Donald Trump's commission

on voter integrity, which has sought to collect voter roll data from all of the states.

Florida County Has 'Thousands' of Voters over Age 100

Lifetzette: As Democrats and the mainstream media continue to insist that the president's voter-fraud commission is a scheme to suppress votes, the head of elections in Broward County, Florida, is appearing in federal court in Miami as a defendant in a lawsuit where she will have to explain why Broward has more registered voters than citizens of voting age — a voter registration rate of 103 percent. And she may also have to try to explain why Broward County, which has the highest number of Democratic voters in the state, has thousands of people over the age of 100 on its roll, and some as old as 130.

New Report Exposes Thousands of Illegal Votes in 2016 Election

A new bombshell study released by the Government Accountability Institute — founded by Peter Schweizer, author of "Clinton Cash" — shows why President Donald Trump's Advisory Commission on Election Integrity has such an important job ahead of it. The institute concluded that thousands of votes in the 2016 election were illegal duplicate votes from people who registered and voted in more than one

state. The institute compared the lists using an “extremely conservative matching approach that sought only to identify two votes cast in the same legal name.” It found that 8,471 votes in 2016 were “highly likely” duplicates.

Extending GAI’s conservative matching method to include all 50 states would indicate an expected minimum of 45,000 high-confidence duplicate voting matches. In the process of identifying potential duplicate votes, GAI found more than 15,000 voters who registered to vote using prohibited addresses, such as post office boxes, UPS stores, federal post offices, and public buildings.

Texas House Pursues Crackdown on Mail-In Ballot Fraud

The legislation would raise several forms of mail-in ballot fraud from misdemeanors to felonies, in order to encourage prosecution. The bill also aims at cracking down on ballot harvesting, where campaign workers fill out voters’ ballots for them. The Senate passed its own bill earlier this week.
