## Democrats Quickly Build Massive Network to Combat Voter ID Laws

Let America Vote has been established by former Democratic Missouri Secretary of State and failed Senate candidate Jason Kander. The group says they are dedicated to "winning the public debate over voter suppression in the United States." The nonprofit appointed high-level liberal operatives to its advisory board. Josh Earnest, President Obama's former White House Press Secretary; Martin Luther King Jr. III, a human rights activist; Stephanie Schriock, the president of EMILY's List; and Jon Favreau, a former speechwriter for Obama; all sit on the 27-person advisory board. Guy Cecil, Chairman of Priorities USA, has also joined the board. Priorities USA was the largest liberal super PAC that backed Hillary Clinton in the 2016 presidential election. Marc Elias, the former top campaign lawyer for Clinton's presidential campaign and a partner at the Washington, D.C. office of the Perkins Coie law firm, is also listed as a member of the advisory board. Priorities will build a national database that's intended to be a "one-stop inventory" on voting measures which it will share with other progressive groups.

## House Panel Votes to Close Election Assistance Commission

Rep. Gregg Harper, R-Miss., chairman of the House Administration Committee, said the Election Assistance Commission has “outlived” its usefulness. The committee voted 6-3 to approve Harper’s measure. It’s not clear yet when and if the House will consider the measure. Harper has introduced a bill four times to eliminate the agency. The House has passed the legislation only once, but the measure may stand a better chance this session in the Republican-controlled Congress.

## Green Card Holder Sentenced to 8 Years of Prison after Illegally Voting in Texas

A permanent U.S. resident was sentenced to eight years in prison and faces eventual deportation after she illegally voted in the 2012 and 2014 elections in Texas. A Tarrant County grand jury found Rosa Maria Ortega, 37, of Grand Prairie, Texas, a Dallas suburb, guilty Wednesday on two counts of illegal voting. Ortega, the mother of four, voted in the November 2012 election and May 2014 GOP primary runoff in Dallas County knowing she wasn’t a U.S. citizen.

## Mexican in Illinois Charged with Vote Fraud

URBANA — A Mexican national who has lived in Urbana since 2005, allegedly using a stolen identity, was arraigned Thursday on seven federal counts, including four related to voting by an illegal immigrant. Miguel Valencia-Sandoval, 33, who allegedly had been using the identity of a Texas man named Ramiro G. Vasquez, pleaded not guilty to the charges before Magistrate Eric Long at U.S. District Court in Urbana.

## Missouri Officials' Next Step: Deciding How to Pay for Voter ID Law

A majority of Missouri residents said they wanted voters to have to show a photo ID at the polls, and lawmakers obliged. Now, state officials must figure out how to pay for the law, which goes into effect June 1. Gov. Eric Greitens has said the budget to implement the law should be \$300,000. Republican Secretary of State Jay Ashcroft said Tuesday that it’ll cost more like \$1.5 million.
